Residential customers in the HMLD service area with an account in good standing are eligible for rebates. Work must be completed between January 1, 2016 and December 31, 2016. Limit: One rebate per HMLD customer of record per calendar year. Applications must be filed by February 28, 2017. HMLD reserves the right to change any portion of this program or end this program at any time without notice.

QUALIFYING PROJECTS: The home improvement project must be part of the ENERGY AUDIT and meet energy efficiency requirements as specified.

HMLD or its designated representative reserves the right to inspect or otherwise verify installation of energy efficient measures.

REBATE AMOUNTS AND PAYMENT: Applications will be processed as they are received. Please allow 4 to 6 weeks for processing rebate payments for qualified applicants.

VERIFICATION: ORIGINAL sales receipt indicating work orders, product, purchase location and price must accompany the Application.

2016 Home Improvement Incentive Program

*If you have a home **ENERGY AUDIT** and complete the recommended improvements, you can reduce energy consumption, lower your electric bill and may become eligible to receive rebates.*

Holden Municipal Light Department (HMLD) is offering our residential customers rebates on insulation upgrades, ENERGY STAR window and storm door replacements through the end of the year. HMLD encourages you to start saving energy by calling Energy New England at 888-772-4242. **A HOME ENERGY AUDIT must be conducted before you are eligible** to receive a rebate. When the energy conservation specialist conducts an **ENERGY AUDIT** of your home, you will receive valuable information on how to save energy right away.*

Then you can save even more by sending in your application for the Energy Smart Home Incentive Program from HMLD, your locally-owned utility.

How does the program work?

HMLD's Home Improvement Incentive Program provides you with energy conservation information about your home. Call the Energy New England Energy Hotline at 888.772.4242 to obtain information about energy efficiency, renewable energy and specific information about your own home's performance.

Callers are asked questions to determine what kind of assistance and services they need. Information about simple ways to save energy in and around the home is also available.

As simple as A-B-C: Audits Before Cash

If energy improvements are needed, the caller is referred to the next step of the program. This includes an **ENERGY AUDIT** of your home's heating and hot water systems, shell insulation, appliances, windows, doors and lighting. An energy conservation specialist conducts the audit by walking through the home, demonstrating ways to save energy. After the audit, a computerized report is given to the homeowner recommending improvements that save energy. When some or all of the recommendations are done by the homeowner or a contractor, the customer completes the Application Form and submits it to Energy New England.

**This program is effective January 1, 2016 through December 31, 2016, or when funds are expended.*

Limit: ONE rebate per HMLD customer of record per calendar year.

What kinds of insulation, door and window projects qualify for incentives?

To qualify for a rebate, you must have an HMLD account in good standing, the project must come from the recommendation made in the Energy Audit, and must be installed within the HMLD service area before the end of the year*.

The following insulation, air sealing, window and door replacement types are the only improvements that qualify for rebates under HMLD's program:

INSULATION & WINDOW TYPES
• Insulation: Attic, Basement, Wall and Rim Joint
• Heating System Pipe Insulation
• ENERGY STAR® Window Replacement**
• ENERGY STAR® Door / Storm Door Replacement
• Air Sealing Measures

50% of cost up to a maximum of \$500

Remember these simple steps:

1. Contact Energy New England at 888-772-4242 to participate in the program.
2. Schedule an ENERGY AUDIT, if you qualify.
3. After the ENERGY AUDIT, complete the qualifying work between January 1, 2016 and December 31, 2016. Limit: ONE rebate per HMLD customer of record per calendar year.
4. Complete the Home Improvement Incentive Application; attach original sales receipts, contractor work orders and proof of payment. Mail to: Energy New England at 100 Foxborough Boulevard, Suite 110, Foxborough, MA 020350; Attn: HII 2016
5. HMLD reserves the right to inspect the installation premises or otherwise verify installation of the insulation, windows or doors.
6. Please allow at least 4-6 weeks for processing incentive credits to customer accounts for qualified applicants.
